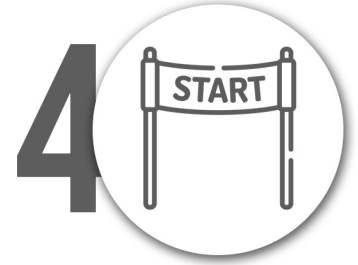
FINANCIAL SUPPORT
